**ASSUMPTION AND ACCEPTANCE OF RISK, RELEASE AND INDEMNITY**

I, \_\_\_\_\_, being aware that snowboarding, alpine, Nordic and freestyle skiing, tubing, mountain biking, horseback riding and such other recreational activities as Bolton Valley Resort may offer throughout the year are recreational activities carrying significant risks of serious personal injury, death or property damage and that there are natural, mechanical and environmental conditions and risks which independently or in combination with such recreational activities may cause property damage, or physical injury, including severe or even fatal injuries to me or others, hereby ASSUME sole responsibility for such risks.

I also acknowledge that I am alone responsible for: (a) my safety while participating in any and all such recreational activities while on Bolton Valley Resort premises or when otherwise engaging in the use or enjoyment of said premises or while going to or from said premises: and (b) providing, utilizing and maintaining the equipment necessary for the safe enjoyment of my participation in such activities. In consideration for Bolton Valley Resort's permission to engage in any such activity, I hereby RELEASE and HOLD HARMLESS the owners and operators of the Bolton Valley Resort, including BVR LLC and their agents, representatives, officers, directors and employees in advance, from any and all liability whether foreseeable or unforeseeable resulting from my participation in any such activity, including any such claims regarding the design or condition of any equipment utilized by me in such pursuits without regard to whether such equipment is specified or recommended by such persons or entities identified herein.

To the extent I am also participating in any such activity which is promoted, sponsored or organized by any individual or entity other than those mentioned above, I also release any such promoter, sponsor, organizer, or club and their agents, representatives, officers, directors and employees from such liabilities and claims as well.

Dear Student and Parent:

The students who participate in the Charlotte/CCS Ski + Ride Program must realize that they take on some responsibilities. Your signatures on the bottom of this letter mean that you have considered and agree with the following:

1. You represent yourself, Charlotte, and Charlotte Central School. You should behave in a respectful and responsible manner. Consequences for inappropriate behavior may include dismissal from the program. Please use common sense and good manners as your guide.
2. If you are involved in damage to CCS, public or private property, you will be required to make restitution to the owner.
3. Transportation to and from Bolton Valley is provided by the program by bus, and, in some cases, private cars driven by parents or chaperones. You must have permission from a parent or guardian to ride to or from Bolton Valley in a private car. You must let one of the Program directors know if you are not riding the bus coming back to CCS.
4. Bus safety and etiquette: Students agree that they will remain seated, (not on their knees facing backward), while the bus is moving, and use their "indoor voices". It is important we do not distract our bus drivers for a safe journey.
5. Please arrange for transportation home as soon as the bus returns from Bolton. It is difficult for chaperones to remain at school until late rides arrive.
